- Management of hard copy books, looseleafs and journals along with corresponding budgets and payment of invoices
- Cataloguing new hard copy and online titles and employing the current library management system
- Carrying out legal/business research and setting up current awareness alerts on behalf of fee earners and business services communities
- Managing the firms CLA and NLA copyright licences, dealing with queries in this area and improving user knowledge (in both the fee earning and business services communities)
- Analysing statistics around enquiries and use of subject materials to ensure best value for money and considering alternative suppliers
- Assisting with new user inductions
- Implementing and maintaining a firm classification system (taxonomy), including taxonomy software systems that meet the requirements of our internal stakeholders across the firm.
